## Important notes:

- If a student is granted credit for previous studies, it will reduce the number of courses (units) required in their selected degree program at ANU. Any credit received will impact upon the choice of courses available to students studying at ANU.
- It is the responsibility of the student to check when specific courses are offered at ANU and to change their program study plan accordingly. More details can be found here: [programsandcourses.anu.edu.au](http://programsandcourses.anu.edu.au)
- It is strongly recommended that students attend ANU Orientation Week or meet with an academic adviser to confirm their program study plan when commencing their studies at the University.
- Students who take the Accounting major (8 courses) are able to complete the major within the two year program. However, if a student wishes to receive professional accreditation from CPA or CA ANZ in addition to the major, they must decline 12 units (2 courses) of unspecified elective credit to create space in the program for the required professional accreditation courses. In this case, the student would receive a total of 36 units (6 courses) of ANU credit, which would extend the duration of the student's program by one semester.
- The above arrangements are correct as of May 2021 for a period of three years and are subject to change.
- Students must achieve a CGPA of 3.0/4.0, where 2.0/4.0 is a pass, in order to be eligible for admission and **up to** one year of credit.
- A minimum grade point of 2.75/4.0, Credit-2 or above is required per course for credit to be granted. If a student does not meet this entry requirement for a course, they will not receive credit for that particular course.
- A maximum of 8 courses or 48 units of credit will be granted towards the selected ANU program.
- Each application for credit transfer will be assessed on an individual basis and the College will make the final decision.
