## Important notes:

1. The above arrangement will be effective for students enrolling after Semester 2, 2021.
2. The above schedule is correct as at May 2021 for a period of three years and are subject to change.
3. If a student is granted credit for previous studies, it will reduce the number of courses (units) required in the selected degree program at ANU. Any credit received will impact upon the choice of courses available to students studying at ANU.
4. It is the responsibility of the student to check when specific courses are offered at the ANU and to change their program study plan accordingly. More details can be found here: [programsandcourses.anu.edu.au](http://programsandcourses.anu.edu.au)
5. It is strongly recommended that students attend Orientation Week or meet with an academic adviser to confirm their program study plan when commencing their studies at the ANU.
6. Students must achieve a GPA 75% or B average, where 60% is a pass, in order to be eligible for admission and up to one year of credit.
7. A minimum grade of C or 65% or above is required per course for credit to be granted. If a student does not meet this entry requirement for a course, they will not receive credit for that particular course.
8. A maximum of 8 courses or 48 units of credit will be granted towards the ANU program.
9. \*-Students must take both BECO001 & BECO002 to be awarded credit for both courses. i.e., if a student takes only BECO001, they will not get credit for ECON1101; they must take both courses.
10. ^-Students must take both BACC001 & BACC002 to be awarded credit for both courses. i.e., if a student takes only BACC001, they will not get credit for BUSN1001; they must take both courses.
11. Each application for credit transfer will be made by the student individually. Student information will not normally be shared between institutions and in any event The Privacy Act 1988 (Cth) shall be complied with. Each application will be assessed on an individual basis and the College will make the final decision.
