In Memoriam:

Jorge Agüero

It is with great sadness that we share with you that Jorge Agüero, who was scheduled to speak at this year's conference, passed away on May 7, 2023 due to complications from pancreatic cancer. We mourn his loss, and extend our deepest sympathy to his family.



Jorge was Associate Professor of Economics and El Instituto at the University of Connecticut, where he has worked since 2013. He was also affiliated with the Institute for Collaboration on Health, Intervention, and Policy (InCHIP) at the university as well as the Group of Development Analysis (GRADE) in Peru.

Known in his fields for his keen eye towards recognising quality research, he served as an editor of the Review of Economics of the Household and the South African Journal of Economics. He was a regular participant in National Bureau of Economic Research (NBER) meetings.

A true scholar with a curious mind, Jorge was excited to talk about ideas with anyone, answering interesting questions with data, but his passion was for research that would improve the lives of the disadvantaged in developing countries. He made incredible contributions in the areas of health, education, discrimination, intimate partner violence and gender, focusing on timely topics with policy implications. He was widely published in top-tier economic journals and received grants for his research from the United Nations Population Fund, the World Bank, and the Inter-American Development Bank, in addition to numerous internal grants from the University of Connecticut.

Jorge was renowned for his wise and caring mentorship of students and colleagues. Born in Lima, Peru, to a family of modest means, he was particularly passionate about mentoring individuals traditionally underrepresented in the field of economics, such as women and minorities.

He will be greatly missed.
