## **Important notes:**

- 1. It is the responsibility of the student to check when specific courses are offered at the ANU and to change their program plans accordingly.
- 2. It is strongly recommended that students attend Orientation Week or meet with an academic advisor to confirm their program study plan when commencing their studies at the ANU.
- 3. Eligible students can choose if they wish to apply for credit or exemption. They are encouraged to meet with ANU program advisor before submitting credit/exemption application.
- 4. Students must achieve a Weighted Average Mark (WAM) of 70% in the SUFE Pre-master Training Program in order to be eligible for credit/exemption.
- 5. A minimum mark of 70% or above is required per course for credit/exemption to be granted. If a student does not receive a mark of 70% or above for a course, they will not receive credit/exemption for that particular course.
- 6. Each application is assessed on an individual basis and CBE will make the final decision as to the student's entry into the ANU program.
- 7. The credit/exemption outlined above is specific for the programs mentioned. If a student chooses to change their program at ANU, this may impact on the credit/exemption they receive.
